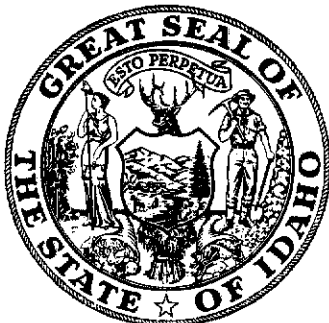

ARTICLES OF INCORPORATION  
OF  
COMMON SENSE SOLUTIONS, INC.

KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, being a natural person of the age of twenty one (21) years or more acting as Incorporator of a Corporation for the purpose hereinafter stated, under and pursuant to the provisions of the General Corporation Laws of the State of Idaho and the Acts Amendatory thereof and supplemental thereto, hereby adopt the following articles of Incorporation for such corporation.

First: The name of the corporation is:

Common Sense Solutions, Inc.

Second: The corporation is to have perpetual existence.

Third: The purpose, or purposes, for which this corporation is organized are:

- (a) To Design, Manufacture, and Bring to Market New Products;
- (b) To Buy, Sell, Trade and deal in and with any and all manner of personal and real property;
- (c) To engage in any and all other businesses permitted to a corporation by the laws of the State of Idaho:

Fourth: The aggregate number of shares which the corporation shall have authority to issue is five hundred thousand (500,000) of one dollar (\$1.00) par value.

Fifth: The private property of the share holders shall not be subject to the payment of corporate debts to any extent whatsoever and the shares of the corporation shall not be subject to assessment for the purpose of paying expenses, conducting business, or paying debts of the corporation.

Sixth: The number of directors of the corporation shall be specified in the by-laws, and such number may from time to time be increased or decreased in such manner as prescribed in the by-laws.

Seventh: The stockholders of this corporation shall be afforded preemptive rights to acquire the corporations unissued shares.

Eighth: The address of the initial registered office of the corporation shall be 4374 Spades Road, Sagle, Idaho 83860, and the name of the Registered Agent at such address shall be Nannette Porath.
