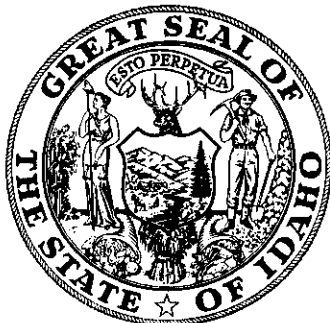

ARTICLES OF AMENDMENT
OF

Pursuant to the provisions of the Idaho Code, Chapter 30, the following Articles of Amendment to Articles of Incorporation are submitted for filing.

I.
