The undesigned, ROXANNE PARRISH, being qualified as an incorporator of a corporation under the Corporation Laws of the State of Idaho, of legal age, enters into these Articles for the purpose of forming a corporation under the laws of the State of Idaho, and does hereby make, adopt, execute, and acknowledge these Articles of Incorporation as follows:

ARTICLE I: Corporate Name

The name of the corporation shall be GLASS CRAFTERS, INC.

ARTICLE II: Duration

The duration of the corporation shall be perpetual.

ARTICLE III: Purposes

The purposes for which this corporation is formed are as follows:

- 1. To construct, produce, manufacture, and assemble products and other personal property; to buy, sell, trade, exchange and install products and other personal property of any character, kind and description; to buy, sell and otherwise deal in products and other personal property.
- 2. To acquire by purchase, buy, sell, trade, own, manage, lease, or otherwise deal with real property and to improve and develop real property. To erect dwellings, apartment houses and other buildings, private or public, of all kinds, and to sell or rent the same. To lay out, grade, pave, and dedicate roads,

streets, avenues, highways, alleys, paths, walks, parks and playgrounds. To buy, sell, mortgage, exchange, lease, let, hold for investment or otherwise, use and operate real estate of all kinds, improved or unimproved, and any right or interest therein.

- 3. To purchase acquire, own, hold, lease, sell, exchange, assign, transfer, mortgage, or otherwise dispose of, and to invest, trade and deal in and with real property, and any and all interest herein.
- 4. To build houses or other buildings of every kind and character, either for sale or lease or on a contract or otherwise; to lay out, subdivide, re-subdivide, and plat tracts of land and sell the same, either by such subdivision or re-subdivision; and to improve streets, alleys, parks and other places, and sidewalk, curb, and otherwise improve the same, and construct and maintain and operate sewers and any and all other conveniences and matters in connection therewith.
- 5. To borrow money, to issue bonds, debentures, notes and other obligations of this corporation from time to time, for any of the objects or purposes of this corporation, and to mortgage, pledge, hypothecate, and/or convey in trust, and or all of its property to secure payment thereof.
- 6. To have offices, conduct its business, and promote its objects within and without the State of Idaho, in other states, the District of Columbia, the territories and colonies of the United States, and in foreign countries, without restriction as to place or amount.
- 7. In general to do all things and perform all acts necessary and proper for the accomplishment of the aforesaid ARTICLES OF INCORPORATION OF GLASS CRAFTERS, INC. 2

purposes and necessary or incidental to the achievement of the objectives of the corporation, and to have and exercise all powers of any nature whatsoever permitted or conferred by law upon corporations in general.

- 8. To transact any and all lawful business for which corporations may be incorporated.
- 9. The several clauses contained in this statement of purpose shall be construed as both purposes and powers, and the statement contained in each clause shall be in no way limited or restricted, by reference or inference from the terms of any other clause, but shall be regarded as independent purposes and powers; and to recitation, expression or declaration of specific or special powers or purposes herein enumerated shall be deemed to be exclusive; but it is hereby expressly declared that all other lawful powers not inconsistent herewith are hereby included.

ARTICLE IV: Shares

The corporation shall have authority to issue 500,000 shares of common stock, which shares shall have a par value of \$1.00 each.

ARTICLE V: Amendments

These Articles of Incorporation may be amended or repealed in any manner now or hereafter prescribed or permitted by statute of the State of Idaho. All rights of shareholders of the corporation are granted subject to this right to amend or repeal these Articles of Incorporation.

ARTICLE VI: Initial Registered Office and Registered Agent

The initial registered office of the corporation shall be located at 47 Davis Road, Sagle, Idaho 83860. The initial registered agent at the address shall be ROXANNE F. PARRISH.

ARTICLE VII: Initial Board of Directors

The number of directors of this corporation shall be not less than one nor more that nine. The initial Board of Directors of this corporation shall consist of one board member, who shall be ROXANNE F. PARRISH, whose address is 47 Davis Road, Sagle, Idaho 83860. The initial chairperson of the Board of Directors shall be ROXANNE F. PARRISH and she shall serve as the Board of Directors until the first annual meeting of shareholders or until her successor has been elected and qualified.
