Pursuant to the provisions of the Idaho Non-Profit Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The following amendment to the Articles of Incorporation was adopted by the Board of Directors and approved by the members of the Corporation in the manner prescribed by Section 30-3-91 of the Act. Article I is hereby revised to read as follows:

ARTICLE I

The name of the corporation shall be **ENGLISH CONGREGATION OF JEHOVAH'S WITNESSES, IDAHO FALLS, IDAHO, INC.**

SECOND: The preceding amendment to the Articles of Incorporation of the Corporation was adopted by the Members and Directors of the Corporation on MAY 12, 2009.

THIRD: The amendment consists of matters other than those described in Section 30-3-90 of the Act, and was therefore adopted by the Members. A resolution by the Board of Directors setting forth the foregoing Articles of Amendment was submitted to a vote of members of the corporation at a meeting of Members held at the Kingdom Hall of Jehovah's Witnesses in Idaho Falls, Idaho on May 12, 2009. Notice of the meeting of Members was given by oral announcement at a regularly scheduled worship service on APRIL 28, 2009 and MAY 5, 2009. The number of members entitled to vote was 101. The number of Members who voted for the amendment was 74. The number of Members who voted against the amendment was 0.

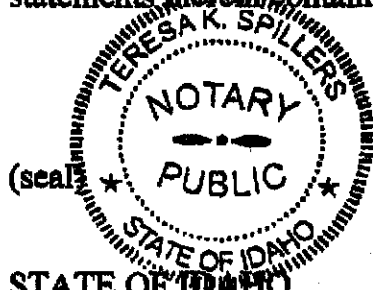

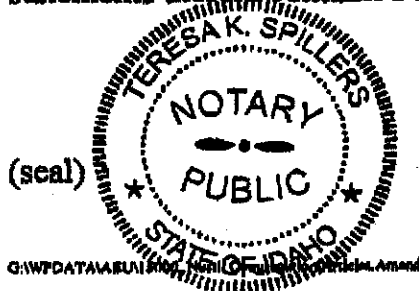
