ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That I, the undersigned, being at full age and a citizen of the United States, have associated myself for the purpose of forming a corporation under the laws of the State of Idaho, and in pursuance thereof, do hereby sign and acknowledge the following Articles of Incorporation in triplicate originals and do state as follows:

ARTICLE I

That the name of this Corporation shall be Terry Lack, Inc.

ARTICLE II

That the objects for which this Corporation is formed are:

- 1. To take, buy, exchange, lease or otherwise acquire real estate and any interest or right therein, and to hold, own, operate, control, maintain, manage and develop them and to construct, maintain, alter, manage, and control directly or through ownership of stock in any other Corporation any and all kinds of building, stores, offices, warehouses, mills, shops, factories, machinery and plants, and any and all other structures and erections which may at any time by necessary, useful, or advantageous for the purposes of this Corporation.
- 2. To take, purchase, or otherwise acquire, and to own and hold such personal property, chattels, chattels real, rights, easements, privileges, choses in action, notes, bonds, mortgages, and securities as may lawfully be acquired and held by it under the laws of the State of Idaho.
- 3. To survey, subdivide, plat, improve, and develop lands for purposes of sale or otherwise, and to do and perform all things needful and lawful for its development for agricultural, residence, trade and business.
 - . To engage in any lawful business in any lawful manner in any place in

statutes, treaties, regulations, and customs thereof, including foreign trade, shipping, air water, rail, automotive, or other transportation, manufacturing, public utilities, mining and development of minerals, oil production, refining, marketing and related businesses, investments, motion, talking or silent, or other visual or sound pictures, or television, or the production of shows or entertainment or the formation of membership clubs, farming, packing, canning, lumbering, real estate, insurance, shipbuilding, salvage, marketing, retail, wholesale, or other business or businesses, operation of hotels, lodging, or housing accommodations of every kind and description, and any other lawful business now or hereafter authorized to be conducted lawfully in this or any other country in the world.

- 5. For any of the purposes of the corporation, to enter into, make, and perform contracts of every kind for any lawful purpose, with any person, firm association, or corporation, municipal body, politic, country, territory, state, government, or colony or dependency thereof; and without limitation as to amount to draw, make, accept, indurse, discount, execute, and issue promissary notes or other evidences of indebtedness of a corporation, whether secured by mortgage or otherwise, insofar as may be permitted by the laws of the State of Idaho.
- 6. To engage in any and all kindred occupations usual or germane to the business hereinbefore expressed, and to exercise every power and authority granted or conferred by the general incorporation laws of the State of Idaho, or under any special laws of said state applying to corporations of this character and to do and perform any and all things necessary, proper or convenient for the carrying out or accomplishment of the objects and the purposes herein specified.
- 7. It is hereby expressly provided that the following enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this Corporation.
