KNOW ALL MEN BY THESE PRESENTS:

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Jeremiah Gotlieb Corporation.

SECOND: The period of its duration is: Perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: The transaction of any lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is: one million (1,000,000) shares of voting common with a par value of \$.23 per share.

FIFTH: Provisions granting preemptive rights are: As contained in Idaho Code Section 30-1-26 and as that section reads this date.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: The incorporators elect not to include such provisions in these Articles.

SEVENTH: The address of the initial registered office of the corporation is The Train Station, Suite 201, 13th and Main, P. O. Drawer 285, Lewiston, Idaho, 83501, and the name of its

initial registered agent at such address is Ron T. Blewett.

EIGHTH: The number of directors constituting the initial board of directors of the corporation is one (1), and the name and address of the person who is to serve as director until the first annual meeting of shareholders or until his successors are elected shall qualify is:

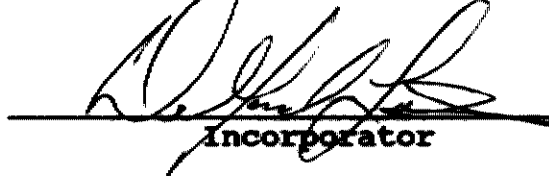
