We, the undersigned, desiring to form a limited partnership pursuant to the laws of the State of Idaho, certify and state:

1. The name of the partnership is C K & M Christensen, Limited Partnership.
2. The character and purpose of the business is to conduct a Farm/Ranch Operation.

10. The partnership may be continued by a substituted general partner, if the existing general partners are dissolved or withdrawn.
11. No limited partner shall have the right to demand and receive property other than cash in return for his contribution.
