AMENDMENTS TO ARTICLES OF INCORPORATION OF THE YELLOWSTONE TRAIL GARAGE COMPANY, INC.

KNOW ALL MEN BY THESE PRESENTS:

That on May 24, 1961, Albert Wellman, Charles Wellman and Frances Wellman, were all directors and stockholders in the Yellowstone Trail Garage Company, Inc., an Idaho corporation; and as such represent the majority of the stockholders of said corporation and the said Albert Wellman, Charles Wellman, and Frances Wellman at that time were and constituted the Board of Directors of said corporation, there being only three directors.

At that time all of the said persons joined in signing an acknowledgment of receipt of a notice of a special meeting of the stockholders of said Yellowstone Trail Carage Company, Inc., aforesaid, and joined in the call and consent to the holding of the meeting and among other things the transaction of the business hereinafter described.

The said notice and consent to the holding of the meeting has since been made a permanent part of the records of said corporation above referred to and is now found in the minute book of said corporation where it was ordered placed by the officers and directors and stockholders of the corporation.

The documents signed by the stockholders, directors and officers of the company provided for the holding of said meeting at the office of the Yellowstone Trail Garage Company, Inc., at Kellogg, Idaho, on May 24, 1961, at 2:00 P.M., M.S.T.

At the time and place and upon the date last mentioned, the said meeting was held. There were present all those who signed said notice, to-wit: Albert Wellman, Charles Wellman, and Frances Wellman.

Albert Wellman, as president of said company and under the power conferred on him by the By-laws, called the meeting to order and Frances Wellman, secretary of the corporation, similarly acted

as secretary of the meeting. The said persons present owned and/ or represented 10,600 shares of the outstanding capital stock of the corporation, it being the majority of the outstanding stock.

WHEREUPON, the Articles of Incorporation were amended as follows, to-wit:

"The names of the corporation shall be changed from the Yellowstone Trail Garage Company, Inc. to Wellman Chevrolet, Inc."

The amendment was adopted by a unanimous vote of the outstanding stock which represented more than a two-thirds vote.

The stockholders present, by unanimous vote directed Albert Wellman, as president, and Frances Wellman, as secretary, to do anything necessary to comply with the laws of the state of Idaho and accomplish the amendments adopted by the meeting as well as make them immediately effective.

The actions taken at the directors' meeting and stockholders' meeting hereinbefore referred to have been made and now are a part of the permanent records of the corporation.
