## ARTICLES OF INCORPORATION OF MOR-GAIN, INC., A CORPORATION

KNOW ALL MEN BY THESE PRESENTS, That we the undersigned, each and all being natural persons of full age and citizens of the United States, have this day and do hereby voluntarily associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho and we do hereby certify:

- (1) The name of said corporation shall be MOR-GAIN, INC., A Corporation;
- (2) The purpose for which said corporation is formed are as follows:
  - (a) To engage in the business of feeding livestock of all kinds, owned by the corporation or otherwise; to enter into contracts for the procurement and placement of livestock in lots, pens and yards owned by the corporation for the purpose of feeding and fattening livestock; to enter into contracts for the feeding and fattening of livestock and for securing payment for the rendition of such services and the costs of such feed; to enter into contracts for the purchasing, financing, loaning upon, the extension of credit therefor and the acquisition, pledging and other dispostion of installment lien obligations or other indebtedness in connection with said livestock program; to incur

expenses and obligations and to guarantee, pledge, borrow or raise monies for any of the purposes of such corporation in any way and to do any such other financing as may be for the welfare of the corporation;

- (b) To engage in the manufacture and sale of foods and any and all supplements thereof for livestock of every kind and to transact all lawful business arising out of the same, together with the manufacture and sale of any and all other useful articles, as may be from time to time determined upon;
- (c) To conduct and carry on the business of buying, selling and dealing in all kinds of grain, hay or other farm products, and farm products and similar products, livestock, and provisions and do a general commission and brokerage business in any or all of the foregoing kinds of property;
- (d) To purchase, rent, lease and sell farms and real property and to engage in the business of farming, and of producing, merchandising, and preserving all kinds of farm fruit, vegetables, and garden products, and of cultivating, growing, harvesting, picking, cleaning and assorting, boxing and packing, storing, buying and selling, at wholesale and retail, all kinds of fruit, vegetables and farm and garden products;

- (e) To breed, raise, import, export and deal in cattle and livestock of all kinds, and to carry on a general cattle or livestock and grazing business; purchasing or acquiring, and selling or otherwise disposing of the stocks, supplies, equipment, accessories, appurtenances, produce and by-products of said business;
- (f) To construct, acquire, operate, hire, lease, mortgage, sell, or otherwise dispose of elevators for elevating wheat, grain or other produce, with the requisite docks, engines, machinery and appliances therefor, and also sheds, stores and warehouses for the reception and storage of wheat, grain and other produce;
- (g) To purchase, improve, develop, lease,

  exchange, sell, dispose of, and otherwise deal in

  and turn to account, real estate, to purchase, lease,

  build, construct, erect, occupy and manage buildings of

  every kind and character whatsoever; to finance the pur
  chase, improvement, development, and constructions of

  land and buildings belonging to or to be acquired

  by this Company, or any other person, firm or

  corporation;
- (h) To engage in a general lumber, timber, kiln drying, milling, construction materials, and merchandise business, to manufacture, purchase, or otherwise acquire, sell, or otherwise dispose of logs, lumber, wood products

in a processed or unprocessed state, and by-products of wood or of said manufacturing operations, in building and construction supplies and merchandise, either wholesale or retain and to engage in the necessary business of hauling and transporting any and all of the goods, wares and merchandise mentioned in these articles.

- (i) To transact the business of advertising, promoting and developing the husiness of other corporations, partnerships or individuals and hire, upon commission, or otherwise;
- (j) To carry on the business of commission dealers or financial agents in all transactions, relating to the sale, transfer or exchange of every description of stocks, shares, mortgages, freehold or leasehold property;
- (k) To do and perform all things and acts specifically enumerated in and contemplated by Section 30-114, Idaho Code and such other acts as are necessary, desirable and expedient to accomplish its purposes;
- (3) The term for which said corporation is to exist is perpetual;
  - (4) The location of post office address is Wendell, Idaho;

- (5) The total amount of authorized capital stock is 250,000 shares of the par value of \$1.00 per share with an aggregate value of \$250,000.00;
- (6) All such stock shall be common and non-assessable, and each and every share issued shall have the same rights and voting powers;
- (7) The business of this corporation shall be managed by a board of at least three directors, and each director must be a stockholder in the corporation, provided, however, that any greater number of directors may be provided for by the by-laws of said corporation;
