AMENDMENT TO ARTICLES OF INCORPORATION

OF

HUDD INVESTMENT TRUST, an Idaho Confidention SEC. OF STATE

In accordance with the Articles of Ingo Appropriation of Hudd III Inc., dated July 22, 1987, Amended to HUDD INVESTMENT TRUST, dated October 23,1987, under File No. 84394 a, the Articles of Incorporation are hereby amended as follows:

ARTICLE NO. 4: PAR VALUE OF STOCK

There being only one class of stock with 200,000 shares authorized, it was the Unanimous vote of all stockholders that the parvalue of the stock shall be at NO-PAR VALUE and the class of stock and authorized shares shall remain the same. There being no dissenting votes, the corporate secretary was authorized to prepare an amendment for the President's signature and filed with the State at a special meeting held by the Board of Directors and all stockholders being present, on May 5th, 1989, held in the office of the corporation in Las Vegas, Nevada.

It is the opinion of the corporate CPA that the change to No-Par Value will have no effect on the stated capital of the stock.
