And we do hereby certify:

1st.-

That the name of said corporation is the SHAW MOUNTAIN GOLD MINING AND MILLING COMPANY, LIMITED.

2nd.-

That the purposes for which this corporation is formed are to own, control, possess, improve, buy, operate and sell that certain mining claim now being and situate in Shaw Mountain Mining District, Boise County, Idaho, said claim being known and located as the North Star lode mining claim, and for the purpose of transacting a general mining and milling business in the aforesaid Counties of Ada and Boise, State of Idaho, said property above described now being owned by the undersigned incorporators, which said property shall forthwith be transferred to said Shaw Mountain Gold Mining and Milling Company, Limited.
