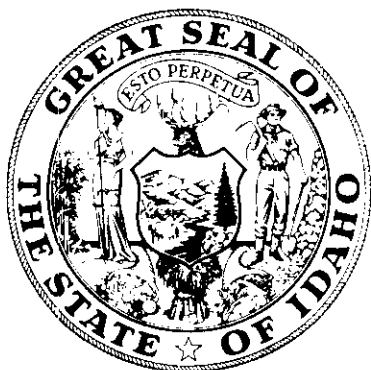
### CERTIFICATE OF WITHDRAWAL OF

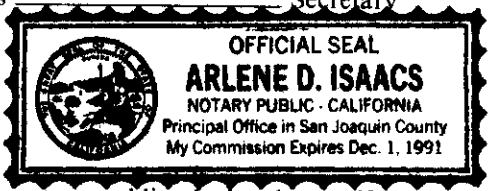
