In the Matter of the Incorporation
of the town of Shelley, Idaho.

A petition having been presented to this Board signed by a majority of the taxable inhabitants of the townsite of the town of Shelley, Idaho, which townsite has not heretofore been incorporated under and laws of this state, praying that they be may be incorporated as a village and designated as the village of Shelly, said petition describing by metes and bounds the territory to be embraced within the limites of said proposed village, and it appearing satisfactorily to the Board that a majority of the taxable inhabitants of the proposed village have signed said petition and that inhabitants to the number of 200 or more are actual residents of the territory described in the petition.

It is hereby ordered and declared that said village be and the same is hereby incorporated and the same is hereby designated as the village of Shelley with boundaries as follows, to-wit:-Beginning at a point 120 rods north of the NW corner of section 33, Twp. 1 N R. 37 E., thence east 120 rods; thence south 280 rods; thence west 240 rods; thence north 280 rods; thence east 120 rods to place of beginning.

And the following named persons are hereby appointed as Trustees for said village of Shelly, Idaho, viz:-John F. Shelley, W. R. Jones, T. J. Bennett, J. W. Evers and Soren Yorgensen. The said persons to hold their office until the election and qualification of their successors and the Clerk is directed to notify said persons of such appointment.
