The undersigned, for the purpose of forming a corporation under the laws of the State of Idaho, does hereby certify, declare and adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation shall be Harks Corner, Inc. (the "Corporation").

ARTICLE II. PURPOSE

The purpose for which this Corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Idaho, as they may be amended from time to time.

ARTICLE III. AUTHORIZED SHARES OF STOCK

The authorized amount of capital of this Corporation shall be, and is, 10,000 shares of no-par common stock, which such stock shall not be issued until fully paid for and once so issued shall be non-assessable. There shall be only one class of shares.

ARTICLE IV. PREEMPTIVE AND PREFERENTIAL RIGHTS

Shareholders of the Corporation shall have preemptive and preferential rights of subscription to any shares of stock of the Corporation, whether now or hereafter authorized, and to any obligations of the Corporation convertible into stock. Any stock or obligations convertible into stock issued by the Corporation shall be offered first to the shareholders of the Corporation.

ARTICLE V. RESTRICTIONS ON THE SALE OF STOCK

The transfer, sale, encumbrance, exchange or other disposition of all or any portion of a Shareholder's shares of stock in the Corporation is expressly restricted by the terms and conditions detailed in the Corporation's bylaws.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT


