



ARTICLES OF INCORPORATION

of

BETA CHI FRATERNITY, INC. 1 18

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, a natural person, of majority age, hereby establishes a corporation pursuant to the Laws of the State of Idaho and adopts the following Articles of Incorporation.

I. Name of Corporation

That the name of this corporation shall be BETA CHI FRATERNITY, INC.

II. Non-Profit Corporation

The corporation is organized as a non-profit corporation under the laws of the State of Idaho.

III. Duration

The corporation shall have perpetual existence.

IV. Purposes and Powers

A. Purposes. The corporation is organized for the development of the social, educational, and benevolent quality of its members; to promote the fraternal spirit of the members; to acquire, hold, sell, assign, and convey such property whether the same be real, personal, or mixed as shall be necessary or convenient for the housing of the members of the corporation, and to do and perform any and all and every act requisite or incidental to the general welfare of the members of the corporation, provided, however, that this corporation shall not engage in any business or activity of any kind for pecuniary profit.

B. Powers. In furtherance of the foregoing purpose, the corporation shall have and may exercise all of the rights, powers, and privileges now or hereafter conferred upon non profit corporations organized under the laws of the State of Idaho.

V. Membership

The corporate membership shall be made up of all initiated members of Delta Mu Chapter of Delta Tau Delta attending the University of Idaho and such other persons as become members in accordance with the by-laws of the corporation.

VI. Distribution Upon Dissolution

Upon dissolution of BETA CHI FRATERNITY, INC., no assets shall be distributed to any members of BETA CHI FRATERNITY, INC. Upon the dissolution of BETA CHI FRATERNITY, INC., all assets shall be distributed to Delta Tau Delta National Fraternity to be used as they see fit.

VII. Continuation of Organization

These Articles of Incorporation for BETA CHI FRATERNITY, INC. are to create a non-profit corporation for the continuation of the prior non-profit corporation named BETA CHI FRATERNITY, whose corporate existence terminated by the terms of its Articles of Incorporation.

VIII. Registered Agent

The initial registered agent shall be James L. Westberg, and the initial registered office shall be located at 414 S. Jefferson, Moscow, Idaho 83843.


