## **ATTACHMENT TO ARTICLES OF INCORPORATION FOR THE THEATRE FACTORY, CO.**

Article 9: The income and earnings of the corporation from whatever source, shall be devoted strictly to corporate purposes. No part thereof shall be transferred to any person except as fair and reasonable compensation for necessary services rendered to the corporation at the request of the directors. The corporation shall not engage in the production of propaganda or attempt to influence legislation or participate in any political campaign on behalf of or against any candidate for public office
