We, the undersigned, desiring to form a partnership pursuant to the Uniform Limited Partnership Act as enacted (A) California, certify that:

1. The name of this Partnership is:

SANDPOINT, LTD.

- 2. The purpose of this partnership is to engage in the business of investing in real estate, and other business activities relating thereto.
- 3. The principal place of business of the partnership is Orange County, California.
 - 4. The name of the General Partners are:

R.A.V., INC., a California corporation. Their place of business is set forth on the signature page hereof.

The name and place of residence or place of business of each limited partner is set forth on the signature page of this Certificate.

- 5. The term for which the partnership is to exist shall commence on date of execution and recordation thereof, and shall continue until terminated by mutual agreement of the parties
- 6. The amount of cash and description of property other than cash contributed by each limited partner is set forth on

the signature page hereof opposite the names of the respective limited partners.

- 7. Limited partners shall not be required to make additional contributions to capital, except if the partnership assets do not provide sufficient liquidation to fund the cash obligations of the partnership, the limited partners may be assessed additional funds in order that the partnership may pay its Note payments as they become due and payable. For that reason, if the General Partner deems it necessary, he may assess each partner in proportion to his partnership interest.
- 8. No partner may withdraw any portion of the capital of the partnership or return on his contribution of capital except on dissolution of the partnership (except that which is realized from selling a partnership interest or refinancing as provided).
- 9. The share of profits which each limited partner shall receive by his contribution is set forth on the signature page hereof.
- 10. A substituted limited partner may be admitted with written consent of all partners, except his predecessor in interest. A limited partner may assign his interest, only after having obtained the consent of all other partners or he has first offered his interest to the partnership on the same terms and with the same conditions as were received by him from any third purchaser.

The partnership shall be entitled to notice in writing from the assigning partner and the identity of any proposed assignee together with the proposed terms and conditions of assignment. Written notice must be given to the General Partner in the form of an offer wherein the partnership shall have ten (10) days in which to accept said offer. If the offer is rejected by the partnership, the assigning partner must offer his interest to the remaining individual partners on the same terms and conditions as received from the prospective assignee. The remaining individual partners shall then be aftorded the same period of time to accept or reject said offer as was afforded the partnership.

11. The partners have the right to admit additional limited partners upon the written consent of the General Partner.



AMENDMENT NUMBER ONE TO AGREEMENT OF LIMITED PARTNERSHIP AND TO CERTIFICATE OF LIMITED PARTNERSHIP OF SANDPOINT, LTD.

The Agreement of Limited Partnership of SANDPOINT, LTD, dated July 1, 1981, by and between R.A.V., INC., a Californian corporation, and the limited partners as listed on the Certificate of Limited Partnership recorded July 14, 1981 as Instrument No. 244456, in Book 92, pages 209-217, Official Records of Bonner County, Idaho, and recorded May 18, 1983, as Instrument No. 83-210566, Official Records of Grange County, California.

NOW, THEREFORE, IT IS MUTUALLY AGREED BY AND BETWEEN ALL PARTNERS HERETO that said Limited Partnership Agreement and Certificate of Limited Partnership be and the same is hereby amended as follows:

 The undersigned partners approve and accept the assignment of all of the 44.184% partnership interest of RICHARD
 VILLELLI effective March 4, 1983 as follows:

- 3. The General Partner in the Limited Partnership known as SANDPOINT, LTD. hereby sells the respective additional interests to the proposed limited partners in the percentage designated opposite their name on the signature page hereof.
- 4. The foregoing designated proposed limited partners hereby purchase and accept such respective limited partnership interests, and acknowledge that the purchase price paid for such interest is the capital contribution amount set forth opposite their name in paragraph 1 hereinabove.

- 5. The Limited Pertners by their signatures herein, hereby specifically approve and consent to the additional capital contributions made by the respective limited partners, and to the issuance of the additional partnership interests as herein set forth and such consent shall be deemed fully effective to satisfy any requirements as to such consent as may be set forth in the original Limited Pertnership Agreement.
- 6. To eliminate the delay in recording partnership amendments, the following provision is hereby added to the Limited Partnership Agreement as a new paragraph 21:

21. Power of Attorney

- 1.1. Scope. By executing the signature page of this Amendment, each of the Limited Partners has appointed the General Partner its true and lawful attorney-in-fact, with full power and authority for him, and in his name, to make, execute, acknowledge, publish, file and swear to in the execution, acknowledgment, filing and recording of:
 - (a) This Limited Partnership Agreement and any separate Certificate of Limited Partnership, as well as amendments thereto, required under the laws of the State of California, or the laws of any other state in which such instrument is required to be filed;

- (b) Any certificates, instruments and documents, including fictitious name certificates, as may be required by, and may be appropriate under the laws of any state or other jurisdiction in which the Partnership is doing or intends to do business;
- (c) Any other instruments which may be required to be filed by the Partnership under the laws of any state or governmental agency, in which the General Partner deems it necessary to file; and
- (d) Any documents which may be required to effect the continuation of the Partnership, admission of an additional or substituted Limited Partner, or the dissolution and termination of the Partnership.
- 1.2. Type of Power. The authority granted to the General Partner in this Article:

- (a) Is a special power of attorney coupled with an interest, is irrevocable, and shall survive the death or dissolution of a Limited Partner;
- (b) May be exercised by the General Partner for the Limited Partners by executing an instrument as an attorney-in-fact for the Limited Partners whose names shall be listed in the instrument as Limited Partners; and
- (c) Shall survive the delivery of an assignment by a Limited Partner of an Interest; except that where the assignee thereof has been approved by the

General Partner for admission to the Partnership as a substituted Limited Partner, the power of attorney shall survive the delivery of such assignment for the sole purpose of enabling the General Partner to execute, acknowledge and file any instrument necessary to effectuate such substitution.

7. All other terms and provisions of said original Agreement of Limited Partnership and Certificate dated July 1, 1981, and all amendments thereto, except as herein specifically amended, shall remain in full force and effect.


