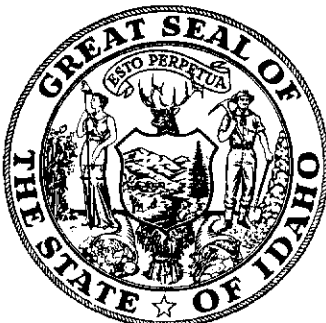
### CERTIFICATE OF AMENDMENT OF

ARTICLES OF AMENDMENT TO THE ARTICLES OF  
INCORPORATION OF ELKHORN MUSIC FESTIVAL, INC.,  
an Idaho not-for-profit corporation
