ARTICLES OF AMENDMENT to the ARTICLES OF INCORPORATION

Pursuant to Idaho Code Section 30-326, Idaho Nonprofit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Hornocker Wildlife Research Institute, Inc.

SECOND: The corporation has had no members since its incorporation on March 11, 1985.

THIRD: The following amendment to the Articles of Incorporation was adopted by the sole director of the corporation on Mark 3 , 1993, in the manner prescribed by the Idaho Nonprofit Corporation Act.

FOURTH: Article <u>FIFTH</u> of the Articles of Incorporation is amended in its entirety to read as follows:

FIFTH: The corporation shall have one (1) class of members; management of the corporation's affairs is vested in its board of directors.
