ARTICLES OF INCORPORATION OF ELK UNLIMITED INC.

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such corporation.

 $\underline{\text{FIRST:}}$ The name of the corporation is ELK UNLIMITED INC.

SECOND: The corporation is a nonprofit corporation.

THIRD: The period of its duration is perpetual.

FOURTH: The nature of the business and the objects and purposes proposed to be transacted promoted and carried on, are to do any or all the things herein mentioned as fully and to the same extent as natural persons might or could do, in any part of the world, to-wit:

To initiate, provide, aid, assist, maintain, develop, sustain, improve and create, programs or projects designed to provide the general public with a perpetual huntable population of Elk in the State of Idaho; including but not limited to habitat, range rehabilitation, access trails, hunting seasons, predation problems, and laws governing game management.

To do any or all of the things herein set forth to the same extent as natural persons might or could do in the

State of Idaho, either alone or in the company with others.

To conduct or transact any lawful business of any type for which a nonprofit corporation may be incorporated under the Idaho nonprofit corporate act.

FIFTH: The corporation is to be a membership corporation having one or more classes of members as set forth in the by laws. The members shall not be personally liable for the debts, liabilities or obligations of the corporation. The management of the affairs of the corporation is to be vested in its membership pursuant to Idaho Code 30-314.

SIXTH: The initial registered office of the corporation is located at 1840 Saint James Avenue, Hayden Lake, Idaho, with the registered agent being MONTY CRAWFORD at said address.
