

ARTICLES OF INCORPORATION.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned residents and citizens of Latah County and State of Idaho, have this 3ed day of July, A.D. 1905, voluntarily associated ourselves together for the purpose of forming a Corporation under the Laws of the State of Idaho.

And we hereby certify:

First:- That the name of said Corporation is the Troy Creamery ~~Company~~ Company, Limited.

Second:- That the purposes for which said corporation is formed ~~is~~ are to carry on a general creamery business in the Village of Troy, Latah County, Idaho.

Third:- That the place where the principal business of the corporation is to be transacted in the Village of Troy, Latah County and State of Idaho.

Fourth:- That the term for which said corporation is to exist is ~~twenty~~ years from and after the date of the incorporation.

Fifth:- That the number of directors of said corporation shall be five, and that the names and residences of those who are elected for the first year are as follows:
