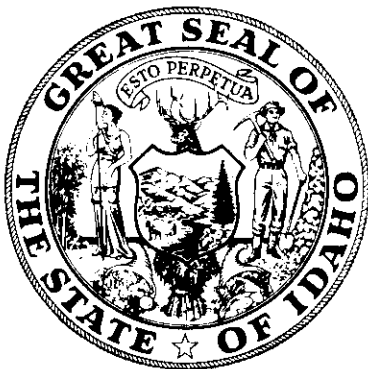

The undersigned, acting as incorporator of the corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for said corporation.

First

The name of the corporation is F. BRION LOWRY, D.D.S., P.A.

Second

The period of its duration is perpetual.

Third

The purposes for which the corporation is organized are to carry on and conduct the rendering of professional services within the State of Idaho in the practice of dentistry, and to have and exercise all powers, privileges and rights conferred on professional service corporations by the laws of the State of Idaho.

Fourth

The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares of common capital stock of the par value of One Dollar (\$1.00) per share.

Fifth

Sixth

The management of the corporation shall be by the shareholders and there shall be no directors, as provided by Idaho Code, Section 30-1-35.


