KNOW ALL MEN BY THESE PRESENTS, that all of the undersigned, being persons of full age and citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the Idaho Business Corporation Act, and acts amendatory thereof and supplemental thereto, do hereby certify the following articles of incorporation:

ARTICLE I.

The name of the corporation shall be **OWYHEE DESERT ESTATES, INC.**

ARTICLE II.

The duration of the corporation shall be perpetual existence.

ARTICLE III.

The purpose of the Corporation shall be to transact any and all lawful business activities for which corporations may perform under the Idaho Business Corporation Act.

ARTICLE IV.

The amount of total authorized stock of the corporation shall be divided into Five Thousand (5,000) shares which shall have a par value of Ten Cents (\$0.10) per share. The shares of stock shall all be common and such shares shall be non-assessable and shall have equal voting rights and all other legal powers. The sum aggregate par value is Five Hundred Dollars (\$500.00).

ARTICLE V.

This corporation hereby reserves the right to amend, alter, change or repeal any provision of these Articles, in the manner now provided or which may hereinafter be provided by law, and all rights, privileges and powers by theses Articles are so conferred subject to this reservation.
