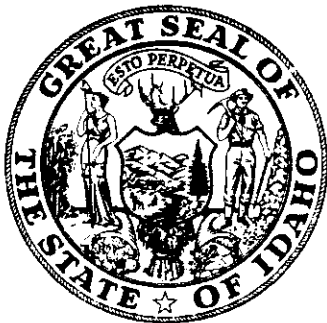

States, for the purpose of forming a corporation pursuant to the

FIRST
