FIRST: That this corporation was incorporated on the 24th day of June, 1965, pursuant to the General Corporation Law of the State of Delaware.

SECOND: That this corporation owns all of the outstanding shares of the stock of IDEAL LEASING CORPORATION, a corporation incorporated on the 17th day of January, 1961, pursuant to the Stock Corporation Law of the State of New York.

THIRD: That this corporation, by the following resolutions of its Board of Directors, duly adopted at a meeting held on the 25th day of August, 1966, determined to and did merge into itself said IDEAL LEASING CORPORATION:

RESOLVED, that LEASCO DATA PROCESSING EQUIPMENT CORPORATION merge, and it hereby does merge into itself said IDEAL LEASING CORPORATION, and assumes all of its obligations; and

FURTHER RESOLVED, that the merger shall become effective on September 30, 1966.
