ARTICLES OF INCORPORATION

The undersigned, acting as Incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Elumbaugh, Inc..

SECOND: The period of its duration is perpetual, unless dissolved by action of the stockholders or by operation of law.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The corporation shall have authority to issue 100 shares of Class A stock, with no par value. The corporation shall have authority to issue 10,000 shares of Class B stock, with no par value.

FIFTH: Provisions denying preemptive rights are as set forth, or as may hereinafter be set forth, in the Bylaws.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are as set forth, or as may hereinafter be set forth, in the Bylaws.

SEVENTH: The address of the initial registered office of the corporation is 28256 Silo Way, Wilder, Idaho 83676, and the name of its initial registered agent at such address is Brandi Elumbaugh.

EIGHTH: The number of directors constituting the initial Board of Directors of the corporation is three (3), and the name and addresses of the persons who are to serve as


