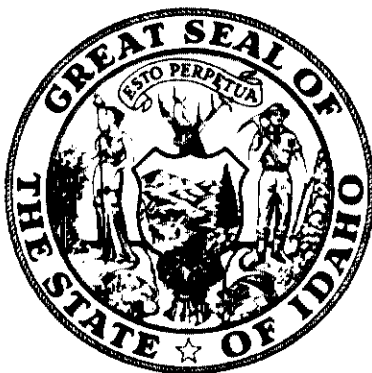

ARTICLES OF INCORPORATION  
for  
SNAKE RIVER CHAPTER OF NAVHDA INCORPORATED

1. NAME:

The name of this nonprofit corporation shall be The Snake River Chapter of NAVHDA Incorporated. ( NAVHDA = North American Versatile Hunting Dog Association).

2. STATEMENT:

The Snake River Chapter of NAVHDA Incorporated shall be a not for profit organization. None of its members, directors or officers shall receive income, dividends or loans from it.

3. PERIOD OF DURATION:

This organization shall be self perpetuating, thus its duration shall be continual.

4. PURPOSE:

The primary purpose of this corporation shall be to serve the community by teaching bird hunters how to train their hunting dogs.

Secondary purposes will be to assist local Fish and Game departments with upland bird habitat, and provide testing and training for bird dogs.

5. GOVERNMENT:

This organization shall be governed by its board of directors who will receive vested authority from the voting membership.

6. MEMBERSHIP:

Membership is open to anyone of any age with interests in keeping with the purpose of the Snake River Chapter of NAVHDA Incorporated, and who are current in their yearly dues. Voting rights are limited to all members 18 years of age or older.

7. BOARD OF DIRECTORS:

The Board of Directors of this corporation shall be its duly elected president, vice president, and secretary-treasurer. Their election and duties shall be outlines in this organizations by-laws.

8. DISSOLUTION:

Should this corporation be dissolved, all assets and/or property shall be given to the international organization of the North American Versatile Hunting Dog Association.
