



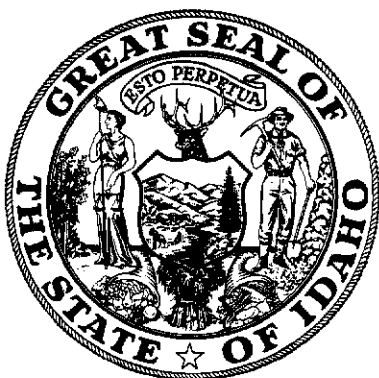
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

SECURITY SERVICES OF IDAHO, INC.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, being natural persons of legal age and acting as incorporator of a corporation, under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST:

The name of the Corporation is SECURITY SERVICES OF IDAHO, INC.

SECOND:

The period of its duration is perpetual.

THIRD:

The purpose or purposes for which the Corporation is organized are: transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH:

The aggregate number of shares which the Corporation shall have authority to issue is One Hundred Thousand (100,000) with a par value of One Dollar (\$1.00) per share. There shall be one class of shares, all of which shall be common shares.

FIFTH:

The address of the initial registered office of the Corporation is 2060 Heather Lane, Idaho Falls, Idaho 83401, and the name of the initial registered agent at such address is Richard A. Riggs.

SIXTH:

The number of Directors constituting the initial Board of Directors of the Corporation is two (2), and the names and addresses of the persons who are to serve as Directors until the first annual meeting of the shareholders, or until their successors are elected and shall qualify are:
