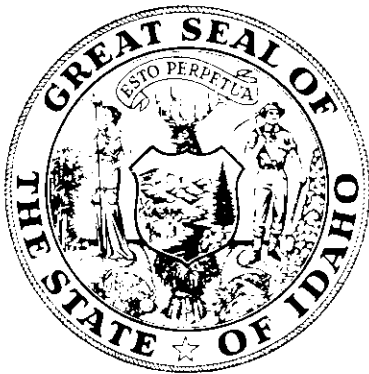

ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION

OF

HIGHWAY EVANGELISM, INC.

Pursuant to Sections 30-325 through 30-327 of the Idaho Nonprofit Corporation Act of the Idaho Code, the undersigned corporation adopts the following amendment to its Articles of Incorporation:

Article VIII is hereby amended to provide that the annual meeting of the membership of the corporation will be held on a date specified in the By-Laws of the corporation.
