ARTICLES OF INCORPORATION  
OF  
COLLECTOR'S GALLERY, INC.

The undersigned, acting as the incorporator of a corporation under the Idaho Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of this corporation shall be Collector's Gallery, Inc.

ARTICLE II

The period of existence and duration of the life of this corporation shall be perpetual.

ARTICLE III

This corporation is organized for the purpose of the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, which may include, but is not limited to retail art sales.

ARTICLE IV

The total number of shares of the corporation shall consist of 100 shares of common stock. No par value is attached to the shares. All shares shall be of one class denoted Common Stock. Each share is entitled to one (1) vote.
