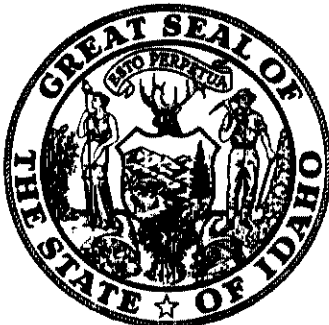
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

OF

MDL, INC.

The undersigned incorporators now adopt the following
Articles of Incorporation of MDL, Inc.:

- A. The name of the corporation shall be MDL, Inc.
- B. The corporation shall have perpetual duration.
- C. The purpose for which the corporation is organized shall be the transaction of any and all lawful business for which corporations may be incorporated under Chapter 1, Title 30, Idaho Code.
- D. The corporation shall have the authority to issue 10,000 shares of no-par stock of one (1) class.
- E. The affairs of the corporation shall be managed by a board of three (3) directors, to be elected by the shareholders.
- F. The shareholders shall meet annually for the purpose of the election of the board of directors, and for such other and further business as may be lawfully conducted at such a meeting. The first meeting of the shareholders shall be conducted within thirty (30) days after the filing of these Articles of Incorporation. Whereupon the board of directors shall be elected to hold office until the next regular meeting of the shareholders. The shareholders shall, at the

organizational meeting, determine the date for the regular annual meeting of the shareholders.

G. No transfer of shares shall have legal effect without the approval of the board of directors, and shall be subject to such other conditions as may be expressed in the by-laws of the corporation.

H. The initial registered office of the corporation shall be at 2283 Wright Avenue, P. O. Box 1601, Twin Falls, ID 83303-1601. The initial registered agent at such address shall be MICHAEL LAW.
