



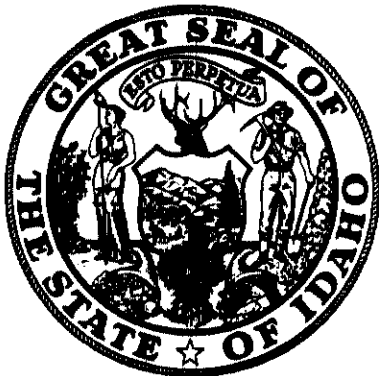
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

of
J.B. INC.

1. The name of the corporation is J.B. Inc.
2. The period of its duration is perpetual.
3. The purpose of the corporation is to transact the business of all lawful activity which a corporation may conduct under the laws of the State of Idaho including, but not limited to the manufacture and sale of equipment, toys, etc., and ownership of all types of property and all activities incidental thereto.
4. The corporation shall have authority to issue 100,000 shares of common stock, all of which shares shall have no par value.
5. The address of the corporation's initial registered office is 737 North 7th Street, Boise, Idaho 83702. The name of its official registered agent at such address is Barry Marcus.
6. The number of directors constituting the initial board of directors of the corporation is two whose names and addresses are:

the first annual meeting of shareholders or until their successors be elected and qualified.

The personal liability of a director to the corporation or its stockholders for monetary damages for breach of fiduciary duty as director is hereby eliminated and no director shall have personal liability to the corporation or its stockholders for monetary damages for breach of fiduciary duty as a director, except that the personal liability of a director to the corporation or its stockholders for any breach of the directors duty of loyalty to the corporation or its stockholders, for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law shall not be eliminated and the personal liability of a director to the corporation of its stockholders for the liability imposed by Idaho Code 30-1-48 shall not be eliminated and the personal liability of a director to the corporation or its stockholders for personal liability for any transaction from which the director derived a legally improper personal benefit shall not be eliminated.
