That the undersigned have this day voluntarily associatednourselves together for the purpose of forming a corporation under the laws of the State of Idaho, not for pecuniary profit.

## AND WE HEREBY CERTIFY:

- 1. NAME. That the name of the corporation shall be the IDAHO VETERINARY MEDICAL ASSOCIATION.
- 2. PURPOSE. That the purposes for which the same is formed are:

The advancement and improvement of the veterinarians of the State of Idaho and of the live stock industry of the State of Idaho.

- 5. PMACE. The place where the principal business of said corporation is to be transacted is the City of Boise, in the County of Ada, State of Idaho.
- 4. TERM. That the term for which said corporation is to sexist is fifty (50) years from and after the date of the incorporation.
- 5. DIRECTORS. That the number of directors of said corporation shall be five (5).
- 6. DIRECTORS FOR FIRST YEAR. The names and addresses of the directors appointed to serve until the first annual meeting of the members of the corporation are as follows:

- 8. QUORUM. The number of directors which shall constitute a quorum shall be three (3) and every decision by a majority of such board shall be valid as a corporated act.
- 8. EXECUTIVE COMMITTEE. The Board of Directors of the corporation shall be and constitute the Executive Committee and may meet at such times and places as the Board of Directors may by resolution or as may be prescribed by the By-Laws and the acts of such dommittee shall be in all matters valid as against the coporation.
