
**CERTIFICATE OF INCORPORATION

We, the undersigned, being adult citizens of the United States of America, do hereby form a corporation pursuant to Chapter 1 of Title 30, Idaho Code, and do hereby adopt and certify the following Articles of Incorporation, to wit:

ARTICLE I: The name of this Corporation shall be THE IMPATIENT SPOUSE MINES, INC.

ARTICLE II: The term of existence of this corporation shall be perpetual.

ARTICLE III: The purposes for which this corporation is organized are the transactions of any and all lawful businesses for which corporations may be incorporated under this act.

ARTICLE IV: The aggregate number of shares which the corporation shall have the authority to issue is 1,000,000; the shares shall all be of common stock; the par value of each share shall be the sum of One Dollar (\$1.00); the total authorized capital stock of the corporation is the sum of One Million Dollars (\$1,000,000.00). The stock of this corporation shall be non-assessable.

ARTICLE V: The address of the initial registered office of the corporation is HC01 Box 15, Weippe, Idaho 83553. The name of the initial registered agent of the corporation at the initial registered office of the corporation is William T. Cole, Sr. The mailing address is HC01 Box 15, Weippe, Idaho 83553.

ARTICLE VI: The corporation shall have five (5) directors, except in the event that all of the shares of the corporation are owned beneficially and of record by fewer than five (5) shareholders, in which event the number of directors may be fewer than five (5) but not fewer than the number of shareholders.
