By consent in writing, two-thirds of the Board of Directors of the Idaho Trails Council, Inc. voted to adopt Article VII to the Articles of Incorporation of the Idaho Trails Council, The SIME Annual Meeting of the members of the Idaho Trails Coucnil Inc. was held on May 14, 1989 at Sun Valley Inn, Sun Valley, Idaho. A quorum was present and a majority of those present voted to adopt and add an Article VII to the Articles of Incorporation of the Idaho Trails Council, Inc. The new article reads as follows:

## ARTICLE VII

"This organization is organized exclusively for charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code."

"Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Interal Revenue Law)"

"Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious and/or scientific purposes and which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code."
