FIRST:

manner for disposition of shares as may from time to time be agreed upon by the shareholders pursuant to an agreement governing purchase and sale of stock.

SIXTH: No director or stockholder shall have personal liability to the corporation or its shareholders for monetary damages for any action taken or any failure to take action, as a director, except liability for:

- 1. The amount of a financial benefit received by a director to which he is not entitled.
- 2. An intentional infliction of harm on the corporation or the shareholders;
- 3. A violation of Section 30-1-833, Idaho Code or
- 4. An intentional violation of criminal law; and

SEVENTH: By majority vote of the shareholders the corporation may indemnify a director for liability, as defined in section 30-1-850(5), Idaho Code, to any person for any action taken, or any failure to take any action, as a director, except liability for:

- 1. Receipt of a financial benefit to which he is not entitled,
- 2. An intentional infliction of harm on the corporation or its shareholders;
- 3. A violation of Section 30-1-833, Idaho Code, or
- 4. An intentional violation of criminal law.
