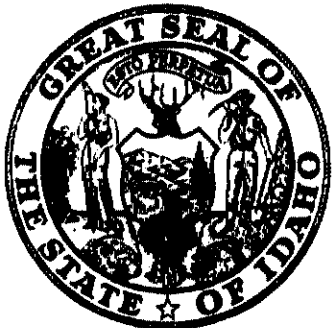

Articles of Amendment to the Articles of Incorporation of HR ENTERPRISES, INC., are herein executed by said Corporation pursuant to the provisions of Section 30-1-59, et seq., of the Idaho Business Corporation Act, as follows:

1. The name of the Corporation is HR ENTERPRISES, INC.
2. The amendment to the Articles of Incorporation of said Corporation is as follows:

ARTICLE I shall be amended to read as follows:

"The name of the Corporation shall be "PARROTT MECHANICAL, INC.", and its existence shall be perpetual."

3. The date of the adoption of said amendment by the shareholders of the Corporation is October 3, 1991.
4. The number of shares outstanding of Corporation is Fifty Thousand (50,000) shares, all of which are entitled to vote.
5. The number of shares voting for and against said amendment, respectively, were as follows:
