# ARTICLES OF INCORPORATION OF THE

# IDAHO BARREL RACING FUTURITY, INC.

KNOWN ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are citizens of the United States of legal age, have this day voluntarily associated ourselves together for the purpose of forming a nonprofit cooperative association under and by virtue of the laws of the State of Idaho relating to nonprofit cooperative associations, and more especially Title 30, Chapter 10, Section 1001, et sequitur, Idaho Code, and we hereby certify:

#### ARTICLE I

The name of this corporation shall be:

IDAHO BARREL RACING FUTURITY, INC. hereinafter referred to as I. B. R. F.

#### ARTICLE II

The purpose for which this corporation is formed are:

- (1) To organize nonprofit associations and corporations and rodeo contestants in the State of Idaho that promote rodeo for the purpose of promoting their mutual protection and benefit.
- (A) To require that all entrance fees be added to prize money with the exceptions being at the discretion of the contestants.
  - (B) To secure competent, honest judges and officials in all events.
- (2) To protect the members against unfairness on the part of any rodeo management.
- (3) To publish information concerning the dates of rodeos, names of contestants, the prize money and other pertinent particulars concerning cowgirls, promoters and sponsors in which the public and members of the I. B. R. F. are interested.
- (4) To work for the betterment of conditions and of the rules governing rodeo events in which members of the Association participate.
- (5) To provide a uniform set of rules for the contestants of the I. B. R. F. and for the quidance and direction of judges of all I. B. R. F. rodeos.

(6) To elect or appoint officers and agents of the corporation who may be directors or members, and define their duties and fix their compensation.

#### ARTICLE III

This corporation shall be in perpetual existence.

## ARTICLE IV

The address of the initial registered office and the name of the initial registered agent of such office shall be: YO MARTS Route #1 Melba, ID 33641

ARTICLE V

No part of the income or assets of the corporation shall be distributed to, to inure to the benefit of any individual.

#### ARTICLE VI

The affairs and activities of this corporation shall be managed by a Board of Directors, consisting of the officers of said corporation, which shall consist of a president, vice president, secretary and/or treasurer, three event directors and the arena directors which shall be established within the membership. At the annual meeting in 1979, after proper notice, the members of the I.B.R.F. who were present voted to elect the following officers to serve for the first year and until their successors are elected and shall qualify:

Said officers will govern this corporation with full authority, subject to the inclusion in the governing body of this corporation of other members of the board of directors as specified above, as said members are duly elected and qualify.
