ARTICLES OF INCORPORATION

OF

KRLC, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, DON THOMAS, ELAINE THOMAS and H. E. STUDEBAKER, each being a natural person of full age, and a citizen of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify as follows:

FIRST

That the corporate name of this corporation shall be:

KRLC, INC.

SECOND

That the purposes and objects for which said corporation is formed are as follows:

(a) To build, erect or otherwise acquire and equip, maintain and operate a radio broadcasting station or stations, and/or television broadcasting station or stations, together with all means of receiving by radio, wire, wireless, or other means, and retransmitting, broadcasting, telecasting, and publishing any and all forms of information and material. The objects and purposes shall include commercial broadcasting, telecasting, entertainment, advertisement, educational instruction, or other material that may be handled over a television or radio broadcasting or receiving station.

(b) To build, maintain, erect, or otherwise acquire and operate any form or type of television or radio station or stations as may be found to be desirable and practical and to do all things necessary to maintain and operate television or radio station service as a public or commercial enterprise and in such manner and for such purposes as may be found to be desirable.

(c) To carry on such forms and methods of collecting and disseminating information, handling advertising matters and doing any form of public work that may be found necessary or helpful in connection with operating a television or radio broadcasting station.

(d) To operate satellite and feeder stations, phonovision and/or multiplexing and such other innovations as may be developed for use by radio or television stations.

(e) To purchase, lease or otherwise acquire in whole or in part, the business, assets, good will, rights, franchises and property of every kind and to take over the whole or any part of such assets and/or the liabilities of any firm, person, association or corporation engaged in or having authority to engage in the same general type of business, authorized to be conducted by this corporation, or owning property, either real or personal, necessary or suitable for its purposes, and to pay for the same in cash, or in the stocks and bonds of this corporation, or otherwise; and to hold or in any manner dispose of the whole or any part of the business or property so acquired, and to exercise all the powers necessary or incidental to the carrying on of such business.

(f) To acquire, buy, own, hold, sell, exchange, let or lease such personal property and real property as may be necessary or incidental to the carrying on of the business of the corporation.

(g) To build any or all buildings, structures, or apparatus as shall be necessary or convenient for the conduct of the business of the corporation or to acquire the same by purchase, lease or otherwise.

(h) To purchase or otherwise acquire, own, hold, mortgage, pledge, sell, assign, transfer or otherwise dispose of shares of capital stock of this corporation.

(i) To enter into any contract, pension trust, cooperative agreement or profit sharing plan with its officers and/or employees which the corporation may deem advantageous or expedient or to otherwise reward or pay such persons for their services as the directors of the corporation may deem fit.

(j) To borrow money for the purposes of this corporation, and to issue bonds, notes, or debentures or other evidences of the indebtedness therefor and to secure the same by mortgage or pledge of personal property, including the income of the corporation, or by mortgage of real or personal property, executed in trust or otherwise.

(k) To exercise generally the powers customarily exercised by business corporations and particularly the powers provided by the laws of the State of Idaho, referring especially to §30-114 Idaho Code.

(l) To carry on any other business, or to do anything in connection with the objects and purposes above mentioned that may be necessary or proper to accomplish successfully or promote the said objects and purposes.

The foregoing clauses, by reason of the specific enumeration of the powers, shall not be held to restrict the power of the corporation to do any of the things within the purview of its general purposes.

#### THIRD

That this corporation shall have perpetual existence.

#### FOURTH

That the number of directors of this corporation shall be three (3), and that it shall not be necessary that any or

all of said directors be a shareholder in this corporation.

FIFTH

That the location and postoffice address of the registered office of this corporation in the State of Idaho and its principal place of business, shall be at Lewiston, Nez Perce County, Idaho.

SIXTH

That the capital stock of this corporation shall consist of 125,000 shares of common stock having a par value of \$1.00 per share and an aggregate par value of \$125,000; each of such shares shall be nonassessable when fully paid for.

The capital stock of this corporation shall not be divided into classes, but shall consist only of one class, that being common stock; each share of stock shall be entitled to one (1) vote in all matters wherein the shareholders of this corporation shall be entitled to vote, and each share shall be in all respects equal to every other share.

SEVENTH

That the name and postoffice address of each of the incorporators and the number of shares of the capital stock of this corporation described in the preceding paragraphs subscribed to by each is as follows:

That the right and power to repeal, alter, rescind and amend the by-laws of this corporation and to adopt new by-laws is hereby expressly conferred upon the board of directors of this corporation as provided in §30-132 (7) Idaho Code.
