ARTICLES OF INCORPORATION ROTATIONALLY APPLIED LEVERAGE TECHNOLOGIES, INC.

We the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of the corporation under the Business Corporation Act, adopt the following Articles of Incorporation for the corporation.

FIRST: NAME. The name of the corporation shall be: ROTATIONALLY APPLIED LEVERAGE TECHNOLOGIES, INC.

SECOND: PERIOD OF DURATION. The period of the corporation's duration shall be perpetual.

THIRD: PURPOSE. The purpose of the corporation shall be the transaction of any or all lawful business for which corporations may be incorporated under this act.

FOURTH: CAPITALIZATION STRUCTURE. The corporation shall have the authority to issue 1,000,000 (1 million) shares of non-par value common stock. Voting rights to be limited to one vote per share.

FIFTH: BUSINESS COMMENCEMENT. The corporation will not commence business until consideration of the value of at least \$1,000 has been received for the issuance of the shares.

SIXTH: PREEMPTIVE RIGHTS. In the event of a future issuance of stock shares, the original shareholders shall be given first option to purchase enough of those additional shares to maintain their proportionate share of ownership.

SEVENTH: BOARD OF DIRECTORS. The Board of Directors shall be limited to five members. The initial Board of Directors shall consist of the following three members who shall serve until the first annual meeting of shareholders or until their successors be elected and qualify:
