Know all men by these presents that I, *Samuel E. Heyman*  
Bishop of the Sharon Ecclesiastical Ward of the Church of  
Jesus Christ of Latter Day Saints, in the County of Bear Lake  
and State of Idaho, having been duly chosen, appointed and  
ordained in conformity with the regulations, rites and discip-  
line of said Church to the office aforesaid, and having legally  
vested in me the legal title of the property of said Church  
situated within the boundries of said Ecclesiastical Ward, do  
hereby make, subscribe and acknowledge these articles of  
incorporation in duplicate for the purpose of becoming a body  
politic, and corporation sole under and pursuant to the pro-  
visions of an Act of the Legislature of the State of Idaho,  
entitled, "An Act providing for the incorporation of Churches  
and Religious Societies " approved February 14th. 1899.

--ARTICLES OF INCORPORATION--

First

The name of this corporation shall be the Sharon Corpor-  
ation of the Church of Jesus Christ of Latter Day Saints.

Second

The object of this corporation shall be to acquire, hold  
and dispose of church property for the benefit of the members  
of the Church of Jesus Christ of Latter Day Saints (a religious  
organization) residing and who may hereafter reside in the  
Sharon Ward of said Church, in the County of Bear Lake and  
State of Idaho, for works of charity and public worship.

Third

The estimated value of the property for which I hold the  
legal title for the purposes aforesaid at the time of making  
and executing these articles of incorporation is *Fifty*  
-----Dollars.

Fourth

The title of the person making these articles of incor-  
poration, is Bishop of the Sharon Ward of the Church of Jesus  
Christ of Latter Day Saints, in the County of Bear Lake, State  
of Idaho.

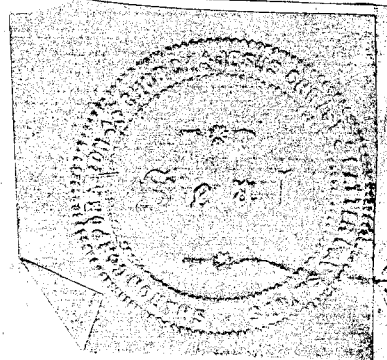
