--ARTICLES OF INCORPORATION--First

The name of thes corporation shall be the Sharon Corporation of the Church of Jesus Christ of Latter Day Saints. Second

The object of this corporation shall be to acquire, hold and dispose of church property for the benifit of the members of the Church of Jesus Christ of Latter Day Saints (a religious organization) residing and who may hereafter reside in the Sharon Ward of said Church, in the County of Bear Lake and State of Idaho, for works of charity and public worship.

Third

The estimated value of the property for which I hold the legal title for the purposes aforsaid at the time of making and executing these articles of incorporation is fifty

Fourth

The title of the person making these articles of incorporation, is Bishoof the Sharon Ward of the Church of Jesus Christ of Latter Day Saints, in the County of Bear Lake, State of Idaho.
