- II. The purposes for which this corporation is formed are:
 - 1. To buy, sell, install, manufacture, process, import, export or otherwise deal in electronic or other equipment, finished products or raw materials, for itself or on contract for other persons, companies or organizations, and for any other lawful purpose.
 - 2. To borrow money, contract debts, make contracts, and to exercise any and all such powers as a natural person could lawfully make, do, perform or exercise which may be necessary, convenient or expedient for the accomplishment of any of its objects or purposes, providing the same be not inconsistent with the laws of the state of Idaho and to that end, enumeration of such powers shall not be deemed inclusive.
- III. The term of existence of this corporation shall be perpetual.
- IV. The registered office of this corporation in the state of Idaho shall be 111 Garland Street, (P.O. Box 41) Nama, Idaho.
- V. The total authorized capital stock of the corporation is twenty five thousand dollars (\$25,000.00) divided into twenty five thousand (25,000) shares of the par value of one dollar (\$1.00) each.
