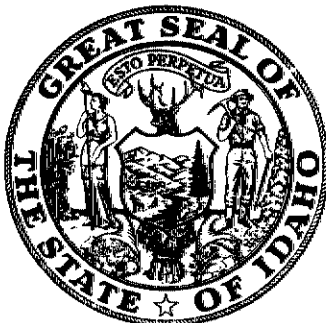

The undersigned, acting as incorporator of a corporation under the Idaho Professional Corporation Act, Title 30, Chapter 13, does hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is Patterson, McHugh, & Kautz, P.A.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are: The above-captioned corporation is a law office. All named individuals are licensed to practice law in the State of Idaho.




