APTICLES OF INCORPORATION

TREASURE VALLEY MARIHA & SPORTING GOODS, INC.

KNOW ALL MEN BY THUSE MEESENTS, That we, the undersigned, being natural persons of least age, and citizens of the United States and bons fide residents of the State of Idaho, do hereby associate purselves together for the nurmose of forming a corporation under the provisions of the laws of the State of Idaho, and do hereby adopt the following Articles of Incorporation, to-wit:

Ι.

The name of the corporation shall be "Treasure Valley Marina & Sporting Goods, Inc."

II.

The nature, objects and purposes for which this corporation is formed shall be:

- (a) To carry on end conduct a general sporting goods business for the buying, selling, manufacturing, lessing, renting, and disposing of all kinds of sporting goods, athletic equipment, apparel, clothing and any kind of fixture or gear directly or indirectly utilized in sporting or athletic activities and events, both wholesale and retail.
- (b) To carry on and conduct a meneral marina business for the buving, selling, manufacturing, lessing, renting and disposing of all kinds of boats, craft, and any other kind of marine transportation, together with all parts, engines, components, fixtures indirectly in connection with said business, both wholesale and retail.
- (c) To buy, sell, lease, rent and dispose of all kinds of appliances, tools, parts, machinery, equipment, and fixtures of all

kinds used directly or indirectly in the sporting goods business and marina business both retail or wholesale, or for ceneral repair, alteration, improvement or the reneral servicing of sporting goods and equipment or for boats, craft or marine equipment.

- (d) To engage in, participate, and take part in, directly and indirectly and to sponser, back, or support others, individuals or groups and associations, in the participation and taking part in sport shows, meets, sames, or any other kind of sporting event, and in boating events, races, regattas or and other kind of marine accivity and water sport.
- (e) To buy, sell and deal in all kinds of contracts, notes, bills of sale, mortgages and other evidences of debt, and the security for the payment of the same;
- (f) To acquire by purchase, subscription or otherwise, and to hold or hypothecate, or to dispose of stocks, bonds, or any other obligation of all kinds: and to sell, trade is and exchange the same, and all classes of stock, bonds, notes, bills of sale and other securities;
- (g) To buy, hold, nurchase, sell, mortrage, lease or exchange real or personal property of all kinds.
- (h) To carry into effect the object and purpose aforesaid, this corporation is authorized to do all and singular the things necessary and convenient to carry out the meneral purposes for which it is organized.
- (i) All the foregoing provisions of this Article II are to be construed both as objects and powers, and it is hereby expressly provided that the enumeration herein of specific powers and objects shall not be held to limit or restrict in any manner the general purposes and powers of the corporation; provided, however, that nothing herein contained shall be deemed to authorize or permit the

corporation to carry on any business or to exercise any power or do any act which a corporation formed under the laws of the State of Idaho now or hereafter existing may not, at the time, lawfully carry on or do. It is the intention that the purpose, objects and powers specified in each of the paragraphs of this Article II shall, except as otherwise, provided, in no ways be limited or restricted by reference to or inference from the terms of any other clause or paragraph in these Articles contained or of any other provisions of these Articles of Incorporation.

IIII.

The duration of this corporation shall be perpetual.

IV.

The location and post office address of the registered office of the corporation is and shall be Boise, Ada Gounty, Idaho.

The total authorized number of shares which may be issued by this corporation is Fifty Shares of common stock with a par value of One Hundred and Mo/100 (0100.00) Dollars per share, and non-assessable. The aggregate par value of the total authoaized number of par value shares is \$5,000.00.

All shares of this corporation are the same class with equal rights and voting power and without preference or priority of any share over any other share.
