ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

THAT WE, THE UNDERSIGNED, natural persons of full age and Citizens of the United States of America, and Citizens and residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a non-profit Corporation under the Laws of the State of Idaho:

AND WE HEREBY CERTIFY:

FIRST

That the name of the Corporation shall be the "CROSSWINDS FLYING CLUB, INC."

SECOND

That the purposes for which this Corporation is formed are:

- A. To promote and encourage among its members an interest in aviation and flying, to furnish or provide or make available any and all manner of flying equipment, materials and services and to promote, sponsor, underwrite, finance and foster aviation and flying events or activities designed to create interest in or understanding of aviation and better the interest of its members in any manner.
- B. To have the right to buy, hold, sell and convey real and personal property such as may be necessary or convenient for the proper conduct of the affairs of the corporation.
- C. To do each and everything necessary, suitable, or proper for the accomplishment of any or all of the purposes, or the attainment of any one or more of the objectives herein enumerated or which shall at any time appear conducive to or expedient for the protection or benefit of this corporation.

- D. Pecuniary profits to the corporation or its members is not the object of this corporation and no pecuniary gain or profit is contemplated.
- E. Subject to the provisions of law, the corporation may purchase or otherwise acquire, hold and re-issue its member-ship certificates.

THIRD

That the place of the principal place of business of said corporation is to be transacted is in the city of Blackfoot, County of Bingham, State of Idaho. The mailing address of the principal place of business will be Route #2, Blackfoot, Idaho.

FOURTH

That the term for which said Corporation is to exist is Fifty (50) years from and after the date of incorporation.

That the officers of this corporation shall be:

President, Vice-President Secretary Treasurer Board of Direct

Board of Directors of not less than five members, or more than seven members, and such other officers as may be provided by these Articles or the by-laws of this Association.

The Corporation shall begin business with a Board of

five members, which may at any time be increased to seven by proper resolution of its Board of Directors.

Commencing with the first annual meeting of the Corporation the Directors shall be elected by the members of the Corporation, and the Directors so elected shall, within ten days after their election, meet and organize and elect from among their number a president and vice-president and shall elect, but not necessarily from among their own number, a secretary-treasurer. The offices of the secretary-treasurer may be filled by one and the same person but neither need be members of the Corporation.

Until the first annual meeting of the Corporation, and until their successors are elected or appointed and qualified, the following named persons shall be officers of the Corporation:

Wayne E. Lyon, Director and President Paul L. Jorgensen, Director and Vice-President Jack Pond, Director and Secretary and Treasurer

The term of office of a director and other officers shall be for a period of one year, or until their successors are elected, and have qualified.

SEVENTH

The private property of the members shall not be liable for the debts and obligations of the Corporation.

EIGHTH

That the rights and interests of all members shall be equal and that the Association shall not issue any capital stock but shall issue membership certificates to each member thereof, which certificates cannot be assigned so that the transferee thereof can by such transfer become a member of the Association, except by resolution of the board of directors and under such regulations as the by-laws may prescribe.

·NINTH

That the Corporation may make and alter the by-laws at pleasure and may authorize the board of directors so to do, subject to such restrictions as may be deemed advisable.

TENTH

That the Corporation may amend its articles of incorporation by a majority vote of its members at any meeting of the members of the association, or at any special meeting of members of the association called for that purpose, on ten days notice to all members.
