ARTICLES OF INCORPORATION

of the

CAMBRIDGE ASSEMBLY OF GOD CHURCH, INC. JUN 11 PM 3 05

The undersigned, acting as the incorporators of a nonprofit corporation under the provision of Chapter 3, Section 30-001, Idaho Code adopt the following articles of incorporation for such corporation.

FIRST: The name of the corporation is: CAMBRIDGE ASSEMBLY OF GOD CHURCH, INC.

SECOND: The period of its duration is perpetual.

THIRD: The corporation is organized exclusively for educational, charitable, religious, scientific, and literary purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.

purpose TO OPERATE A CHURCH
FOURTH: The corporation shall have all the powers granted by law necessary and proper to carry out its above-stated purposes, consistent with its qualification under Section 501 (c) (3) of the Internal Revenue Code.

FIFTH: In the event of dissolution, the assets of the corporation shall be distributed only to a recipient or recipients to be selected by the board of directors that would qualify for exemption as an organization described in Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended, as a successor statute.
