## ARTICLES OF AMENDMENT (Professional Service Corporation)

Title 30, Chapters 21 and 29, Idaho Code

Article 3 shall be amended as follows:

Amendment 1 - Shareholder Stephen R. Witek has formally divested any and all interest in SEEDIdaho P.C DBA SEEDIdaho effective December 31, 2021. This notification was made both verbally and via electronic mail to associate shareholder Michael S. Jones on January 20th, 2022. The reasoning for this divestment as described was of a purely personal nature.

Amendment 2 - Shareholder Stephen R. Witek hereby relinquishes all 51 shares, with a Par value of \$0.01 per share, and his position as Vice President.

Amendment 3 - Shareholder Michael S. Jones hereby takes ownership of the 51 shares relinquished by Stephen R. Witek. This action makes Michael S. Jones the sole owner of SEEDIdaho P.C. This amendment increases the total number of shares owned by Michael S. Jones from 49 to 100 shares

Article 2 shall be amended as follows:

Amendment 1 - The SOS has requested a copy of the Certificate of Authorization from the Idaho Board of Licensure of Professional Engineers and Professional Land Surveyors. Michael Jones will continue to be the Engineer in responsible charge. Michael Jones' Idaho PE license number is 14793.
