

- 1. It owns all of the issued and outstanding stock of HALLANGER ENGINEERS, INC., a corporation, duly incorporated on September 17, 1971, under the laws of the State of California.
- 2. The following resolutions were adopted by the Board of Directors of DAVY McKEE CORPORATION:

FURTHER RESOLVED, That the President or Vice President and Secretary or Assistant Secretary of this Corporation are hereby empowered to execute and file a Certificate of Ownership and Merger pursuant to Section 253 of the Delaware General Corporation Law and Section 1110 of the California Corporation Code.

- 3. Said resolutions were adopted at a special meeting of the Board of Directors of this corporation, held on January 30, 1981, at 10:05 a.m. at Cleveland, Ohio. This corporation has seven directors, a quorum of whom were present at such meeting and said resolutions were adopted by unanimous vote of the directors.
- 4. This Certificate of Merger shall be effective as of the close of business on March 31, 1981.
