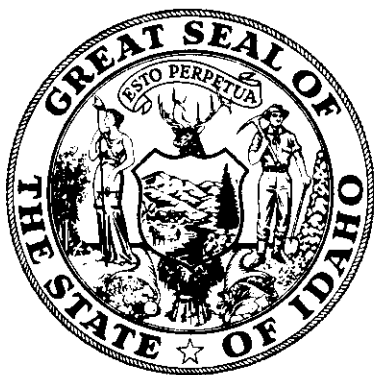

ARTICLES OF INCORPORATION  
OF  
MAGIC VALLEY DIVERS, INC.

The undersigned, acting as Incorporator of a corporation under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such Corporation:

I.

The name of the Corporation is MAGIC VALLEY DIVERS, INC.

II.

Its duration is perpetual.

III.

The purposes for which the Corporation is organized are to promote scuba diving; to promote water safety; to acquire equipment to be used in scuba diving and for any or all other lawful purposes for which this Corporation may be incorporated under the Idaho Nonprofit Corporation Act.

IV.

MEMBERSHIP CORPORATION

The Corporation is to be organized upon a non-stock, certificate of membership basis. Such membership shall be non-redeemable, non-transferrable and non-dividend bearing.

V.

ELECTION OF DIRECTORS

Directors of the Corporation shall be elected in the manner provided by the By-Laws.

VI.


